We received eight (8) proposals and after the paper screening process was completed, we selected six (6) firms to interview. Our panel of seven individuals, including five District staff, one Board member, and the District's Division of State Architect inspector, interviewed each firm.

The interview panel considered many factors that included, but were not limited to, experience in the K-12 Architectural arena, references, location, knowledge of our district properties and the district's Facilities Master Plan, written and oral presentations and ability to work with our staff.

The Board of Trustees requested staff bring forth the top two (2) Architectural Services firms for consideration and approval of the firm that best fits the needs of Orcutt Union School District. The interview panel selected SVA Architects as their first choice and Rachlin Architectural Services as their second choice.

RECOMMENDATION:
