BOARD AGENDA ITEM: Purchase of Switches and Maintenance Agreement

BACKGROUND: Three years ago, the board approved a total upgrade of our data network infrastructure to provide a Gigabit Ethernet Network to each workstation. This was accomplished by replacing the aging CISCO

switches with new Extreme switches. There were over 125 switches

replaced in total.

Extreme offers warranties for software upgrades, repair and replacement for a yearly fee. I am recommending that the district purchase the warranty for the following switches:

 The Black Diamond main switch at the district office head-end room. This switch manages ALL traffic leaving and entering the district as well as allowing all switches in the district to communicate internally.

The Extreme switches (97004-X450A-24X and 97004-X250E-48T) at each of the following five schools — Pine Grove, Nightingale, Shaw, Dunlap and Lakeview. Similar switches are not installed at Orcutt JH and the Academy High School as those schools run directly off the Black Diamond mentioned above.

At each school there are a number of smaller switches which connect the school head-end rooms with the classrooms. These are relatively inexpensive and Janet Bertoldi recommends we buy eight "spares" which can be used as replacements rather than paying for warranties. She believes this is a better use of her limited funds. The reason for purchasing eight is because when they start to fail, they fail in batches.

Trace3 submitted a quote for \$8,466.00 for the purchase of the eight switches and \$11,099.55 for the warranty agreement.

Relational Technology Solutions (RTS) submitted a quote for \$16,721.00 for the warranties. The representative said that Extreme only offers special pricing for new switches to one partner (Trace3), so

RTS would not submit a quote for the new switches.

RECOMMENDATION: It is recommended that the Board of Trustees approve the contract with

Trace3 for the purchase of switches and warranty agreement as

proposed for a total contract amount of \$19,565.55.

Board Agenda Item: Approval of Purchase of Compass Learning Curriculum

Background:

Compass Learning is an online, research based curricula that delivers targeted, explicit instruction that is aligned with state and national standards. It utilizes a variety of instructional approaches and differentiates instruction to keep students motivated and engaged. It offers 24 hours a day, 7 days a week access to the curriculum as well as offline activities. The program has been piloted this year at three of our schools – Alice Shaw, Patterson Road, and Orcutt Junior High School. The curriculum includes language arts and math as well as science, social studies, writing, and brain buzzers (fun, project-based activities utilizing curricula from all core content areas which encourage higher-order thinking skills through analysis).

Compass Learning has partnered with NWEA, which enables each child's program to be designed at their instructional level – individualized for their strengths and weaknesses – based on their RIT score for each of the goal performance areas within the Measures of Academic Progress. Each time students take NWEA, their folders will be re-programmed based on their new scores. Additionally, teachers can assign additional activities based on the instructional program in the classroom.

While the data gathered during the pilot is limited due to the short pilot window, student achievement trends from the schools that participated in the pilot are positive. The pilot schools excelled at a higher rate in several areas of focus in our district including reading comprehension, writing applications, math reasoning and algebra and functions as compared to non-pilot schools. Additionally, the curriculum appears to have a positive effect on

elementary students that are below standard and a positive effect on junior high students that are above standard.

Funds used for the purchase of the program will utilize budgeted intervention funds set aside for the purchase of an online program. These funds were budgeted for this fiscal year (2011-12) but have not yet been expended. The initial purchase includes the curriculum, NWEA fee, hosting fee, and professional development/coaching. There will be an annual fee for hosting and NWEA alignment beginning in the 2013-14 school year that will range from \$4,087 - \$5,084 per school based on grade span.
